

Consent to the processing of personal data of holders of the multi-functional identification card of the University of Economics, Prague associated with the ISIC / ITIC license

The consent is granted pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27th, 2016 On the Protection of Individuals with Regard to the Processing of Personal Data and on the Free Movement of Such Data (hereinafter referred to as "GDPR"), Act No. 110/2019 Coll., On Personal Data Processing (hereinafter referred to as "APDP"), and Act No. 480/2004 Coll., On Certain Information Society Services and on Amendments to Certain Acts for the purpose of issuing and using the multi-functional identification card of the University of Economics, Prague associated with the ISIC / ITIC License (hereinafter referred to as the "Card").

The personal data administrator is the University of Economics, Prague, registered office in Prague 3, W. Churchill Square 4, Postcode 130 67, Company Identification Number: 61384399 (hereinafter referred to as the "University"). The scope of personal data processed for issuing and using the Card is the name, surname, date of birth, validity of the Card (from/to), serial number of the Card, the Card status and its type, the UID (chip) of the Card, name of the University; and in case of students: their status and form of study (hereinafter referred to as "Personal Data").

The data are processed in order to issue the Card and keep records of Cardholders and their verification and control, i.e. confirm the user's status for obtaining benefits, and to use the Card for all its functions within the University according to the University's internal regulations, as well as Rector's orders published at www.vse.cz. Information on the access to Personal Data and their processors is available at www.isic.cz. The processing period equals the duration of employment/study at the University, but no more than nine (9) years from the date of issuing the Card.

Use of the Card outside the University:

By signing this consent, I agree that the University shall transmit my Personal Data to GTS ALIVE s.r.o., with its registered office in Prague 1, Letenská 118/1, Postcode 11800, Company Identification Number: 26193272, and that GTS ALIVE s.r.o. can process and use the data for the purpose of operating the Card and checking its validity, i.e. validating the Card serial number for drawing benefits associated with the ISIC / ITIC license, and send me information regarding the use of the Card such as information about the Card expiry, instructions for use and other information for using the Card, in all ways, as well as by electronic means for the period of the Card validity or until my consent is revoked. Information about processing and my rights can be found at www.isic.cz.

I understand that GTS ALIVE s.r.o. as the processor of Personal Data is entitled to conclude a contract with a sub-processor on the processing of Personal Data for individual acts of processing such data. The processors are listed at www.isic.cz. Currently, Orchitech Solutions, s.r.o., Company Identification Number: 28246764, with its registered office in Prague 3, Koněvova 2660/141, postcode 13000, is such sub-processor.

Furthermore, I agree that GTS ALIVE s.r.o. can submit my Personal Information to the ISIC Global Office (IGO), with its registered office and business address Keizersgracht 174 -176, 1016 DW Amsterdam, The Netherlands, for the purpose of verifying the Cardholder and checking the discount/benefit entitlement for the ISIC / ITIC Cardholder.

I certify that I have been advised of my rights: 1) the right of access to information (whether, for what purpose and how it is processed); 2) the right to rectify and complete personal data; 3) the right to erase the personal data; 4) the right to restrict the future processing of personal data; 5) the right to the portability of personal data in a legible form for the purpose of their transfer to another administrator if the processing is automated; and 6) the right to object to the processing.

I grant my consent voluntarily, and I am aware that I can revoke it at any time, in the same way as I gave it.
